GERSYS Managing Director Pöderl will leave company by mutual agreement

In the course of a group-wide restructuring of top management at the HÜBNER Group, Olaf Pöderl, who has been serving as Managing Director of GERSYS GmbH, will leave the company in September 2020 to take on important responsibilities outside the company.
